Work Underway: Representations of Refugee Policy and Governance: A Constitutional Ethnography of the U.S. and Germany. With record numbers of refugees and migrants living in places and contexts in which they have no secure settlement status, this project contributes to our knowledge on durable solutions by providing insight into the variation of policy and governance across localities in Western Liberal Democracies that have already accepted sizable numbers of refugees and migrants. Through research on the workings of local interpretive communities as they invoke constitutional rules, norms and principles to operationalize refugee policies, the project contributes to our understandings of Western liberal constitutionalism as a form of governance that is separate from cultural norms and values and the ways in which constitutional rights and governance contributes to settlement of refugees and asylum seekers in a locality. The creation of a digital archive will involve students in mapping, documentation and curation of source material that contributes to curricular development in new courses – *U.S. Refugee Policy and Localities* and *Constitutional Challenges in Comparative Perspective*.
