Research in progress

“The Politics of Black Suburbanization,”

This project explores the effects of suburbanization on the political behavior and attitudes of African Americans. We know very little about the political lives of the growing numbers of poor and middle class African-American suburbanites. Their political participation patterns, policy preferences, and ideas about their racial identity remain understudied. This study aims to help fill this gap in the academic literature and add to our understanding of this important dimension of post-Civil Rights era Black political life.

“Nativity and Black Political Participation in the United States: A Comparative Study of African Americans and Black Immigrants,” with Mosi Ifatunji

This study explores a surprising paradox documented in the existing research on Black political behavior. Foreign-born Blacks tend to match or exceed their native-born Black counterparts in socioeconomic outcomes; yet they trail behind them in rates of political engagement, most notably voting but other activities as well. In short, foreign-born Blacks’ success in the labor market and economy has not translated to politics. Our project investigates the sources of this political disparity between native- and foreign-born Blacks and considers its broader ramifications. We examine intergroup dynamics, voting behavior, and political attitudes.
